#### **CONSENT AGENDA**

Jim Lewis motioned and Kay Harrison seconded approval of the consent agenda consisting of minutes of the August 15, 2018 Board Meeting. The motion carried with a unanimous vote of the all board members.

## **RESOLUTION 18-25: STORMWATER QUALITY MANUAL**

Jennie Morgan explained that this resolution accepts the new Stormwater Quality manual that was accepted by the SWAT in July.

Bill Stults motioned and Jim Lewis seconded approval of Resolution 18-25. The motion carried with a unanimous vote of the all board members.

#### RESOLUTION 18-26: AWARD OF BID FOR L003-LAGOON IMPROVEMENTS

Carl Tappert explained that approval of this resolution will award the contract to build a Vactor dump station at the lagoons. This will be a two bay dumpsite. Staff recommends award of the contract with Knife River in the amount of \$90,520

Kay Harrison and Bill Stults seconded approval of Resolution 18-26. The motion carried with a unanimous vote of the all board members.

## **PROJECT UPDATES**

Engineer Nick Bakke would like to partner with a private developer, Coast Aluminum, to realign and replace approximately 712 feet of existing deteriorating 12" concrete sewer on South Pacific Hwy north of Phoenix. This is the old South Medford Sanitary District. RVSS will reimburse the developer for the costs associated with the added sewer.

Kay Harrison motioned and Brown seconded approval of the agreement with Coast Aluminum. The motion carried with a unanimous vote of the all board members.

The solar panels have been installed Dunn Pump Station. RVSS is still waiting on a new meter to be installed by Pacific Power and a router for internet access.

The draft facilities plan for Gold Hill has been submitted to DEQ and they have indicated that this could take as long as three months to review.
